Health Record Requirements for Students Entering Rockton School District #140 2021/2022

The Rockton School District nurses welcome your family to our schools! This letter provides details about the required health records for each grade level. We hope you find it helpful. The contact information for the nurse at your child's school is listed at the end. Feel free to contact us with questions. We are in and out of the office the week before school starts. Please leave a voice message if we are unavailable and we'll get back to you the next time we are there.

Pre-Kindergarten and Early Childhood- (If your student is new to the program)

Physical Exam: due before the first day of attendance and must be on an Illinois exam form dated after 9/3/2020. The health history portion must be completed, signed, and dated.

**This must be handed in before the first day of attendance, or first-day exclusion will apply. Your student will not be allowed to attend school until this has been provided.

Immunizations: must be up-to-date as required by the State of Illinois and provided to the school before the first day of attendance.

Kindergarten

Physical Exam: due before the first day of attendance and must be on an Illinois exam form dated after 9/3/2020. The health history portion must be completed, signed, and dated.

**This must be handed in before the first day of attendance, or first-day exclusion will apply. Your student will not be allowed to attend school until this has been provided.

Immunizations: must be up-to-date as required by the State of Illinois and provided to the school before the first day of attendance.

Eye Exam: (performed by an ophthalmologist or optometrist) due by October 15, 2021, and must be on an Illinois exam form dated within 1 year of handing it in. For example, if you give it to the school on 8/21/2021, it must be no older than 8/21/2020.

Dental Exam: due by May 15, 2022, and must be on an Illinois exam form dated between 11/15/2020 and 5/15/2022.

2nd Grade

Dental Exam: due by May 15, 2022, and must be on an Illinois exam form dated between 11/15/2020 and 5/15/2022.

6th Grade

Physical Exam: due before the first day of attendance and must be on an Illinois exam form dated after 9/3/2020. The health history portion must be completed, signed, and dated.

**This must be handed in before the first day of attendance, or first-day exclusion will apply. Your student will not be allowed to attend school until this has been provided.

Immunizations: must be up-to-date as required by the State of Illinois and provided to the school before the first day of attendance. Additional immunizations required for 6th grade include:

-Proof of Tdap vaccine is required for all students entering 6th grade.

- Meningococcal Conjugate Vaccine is required for all students entering 6th grade. This must be administered **on or after** 11 years of age. If your student will not be 11 years of age before entering 6th grade, the physician must provide a note stating the scheduled date for the immunization.

Dental Exam: due by May 15, 2022, and must be on an Illinois exam form dated between 11/15/2020 and 5/15/2022.

Illinois Residents New to the School District

Physical Exam: due before the first day of attendance and must be on an Illinois exam form dated after 9/3/2020. The health history portion must be completed, signed, and dated.

**This must be handed in before the first day of attendance, or first-day exclusion will apply.

Your student will not be allowed to attend school until this has been provided.

Immunizations: must be up-to-date as required by the State of Illinois and provided to the school before the first day of attendance.

Eye Exam: (performed by an ophthalmologist or optometrist) due by October 15, 2021, and must be on an Illinois exam form dated within one year of handing it in. For example, if you give it to the school on 8/21/2021, it must be no older than 8/21/2020.

Dental Exam: due by May 15, 2022, and must be on an Illinois exam form dated between 11/15/2020 and 5/15/2022.

Students New to Illinois

Physical Exam: due within 30 days of registration and must be on an Illinois exam form dated after 9/3/2020. The health history portion must be completed, signed, and dated.

Immunizations must be up-to-date as required by the State of Illinois and provided to the school before the first day of attendance.

-Proof of Tdap vaccine is required for all students entering 6th grade.

- Meningococcal Conjugate Vaccine is required for all students entering 6th grade. This must be administered **on or after** 11 years of age. If your student will not be 11 years of age before entering 6th grade, the physician must provide a note stating the scheduled date for the immunization.

Eye Exam: (performed by an ophthalmologist or optometrist) due by October 15, 2021, and must be on an Illinois exam form dated within one year of handing it in. For example, if you give it to the school on 8/21/2021, it must be no older than 8/21/2020.

Dental Exam: due by May 15, 2022. It must be on an Illinois exam form dated between 11/15/2020 and 5/15/2022.

If your student's grade level is not listed, and he/she is not new to the state or district, there are no new requirements.
