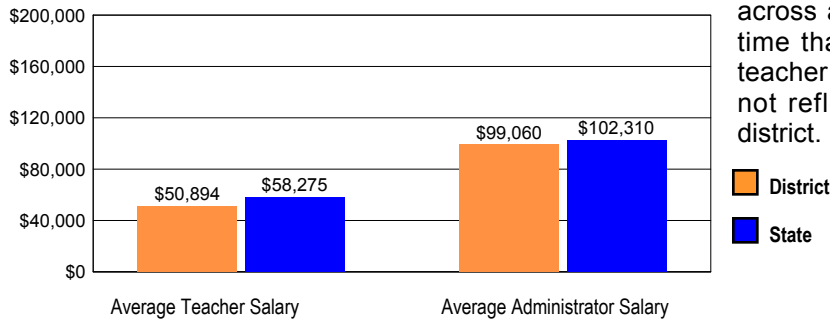

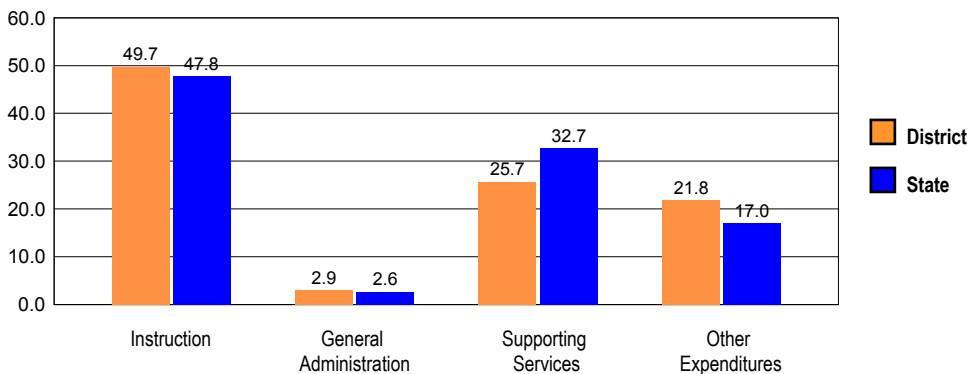
SCHOOL DISTRICT FINANCES

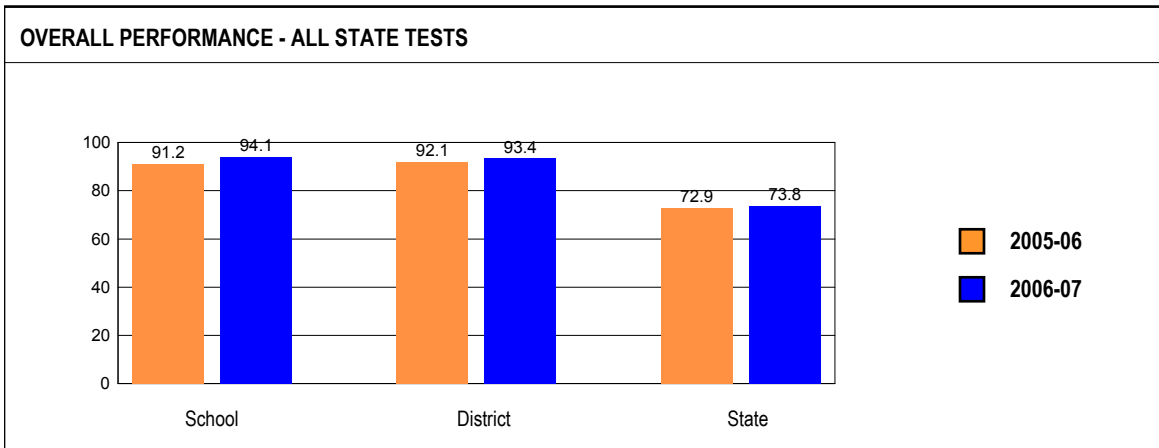

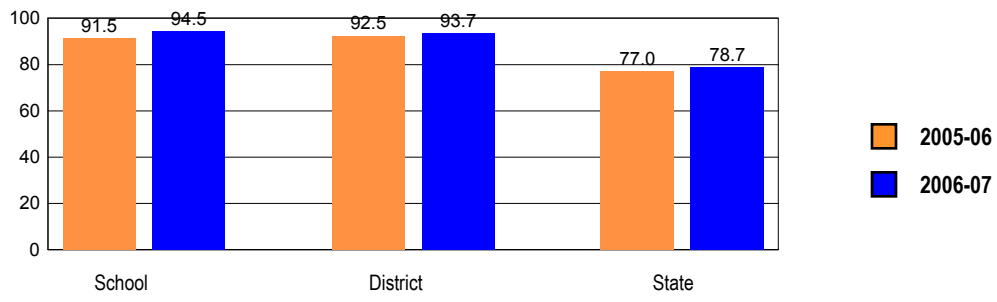

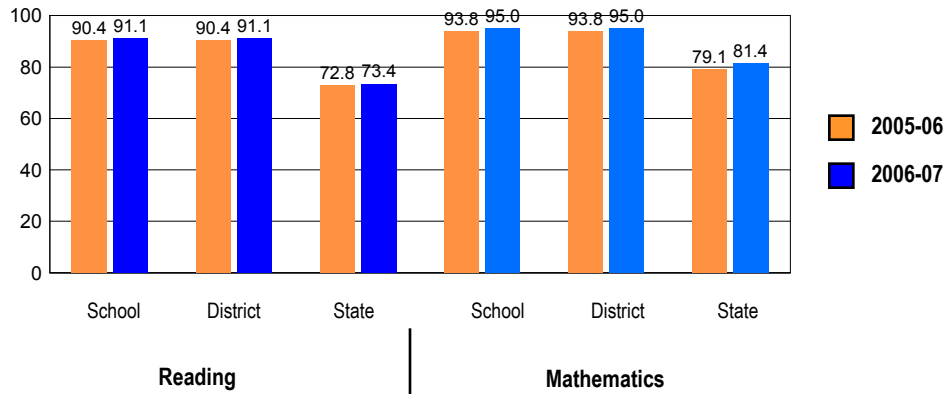
OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE



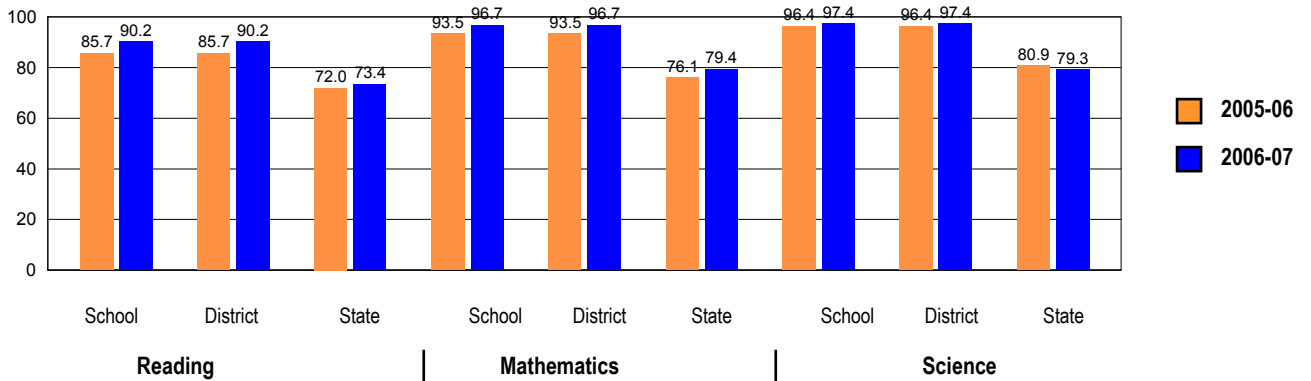

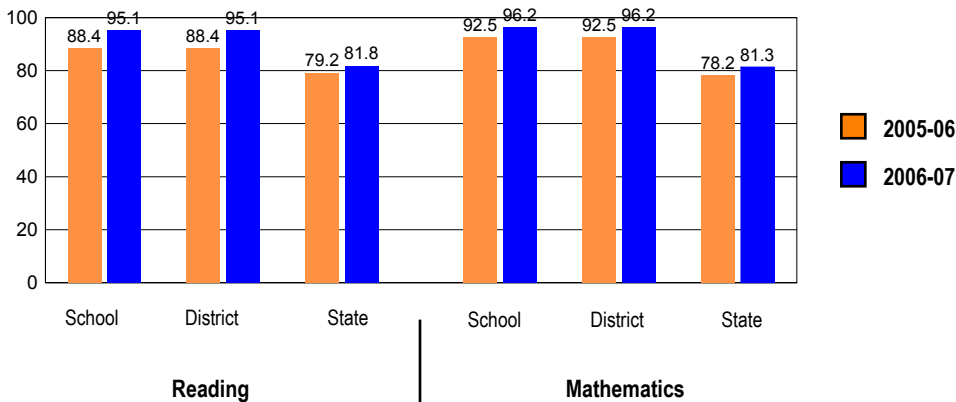
ISAT Grade 6

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT

Stephen Mack Middle School is an academically challenging middle school with high teacher and student expectations. Our curriculum is continually evolving and improving, as is evidenced by our ISAT results.

Nevertheless, the state standards and implementing our standards-based curriculum are the main components of our 2007-2008 School Improvement Plan. In our middle school, every student has a reading class. However, technical reading occurs in every class, especially science and social studies. We identified that our staff could do a better job of preparing their students for success with technical, content-area reading, but that this was too big a task merely to be part of the reading class. This year, our staff has been receiving instruction on best practices for teaching their students how to read technical content-area material for each particular curriculum area. We have already accomplished a small part of this improvement and look forward to continuing this improvement effort with hard data to back it up.

At Stephen Mack, our ultimate goal is for 90% of our students to meet or exceed state standards in every curriculum area with an increasing percentage exceeding each year. While this is an ambitious target, it is not unobtainable. In 2007, we reached this goal in all areas except eighth grade writing, where 86% of the students met or exceeded state standards. In 2008, all sixth and eighth grade students will be testing in writing and we are making this critical skill a focus of our school improvement planning process for the year.

To improve our school curriculum, the school district has hired a curriculum coordinator to assist in developing a comprehensive K-8 and beyond curriculum plan. Our teachers are realigning what they teach and when. We are working closely with Hononegah High School to dovetail our curriculums, assuring the ultimate success of our students in high school and beyond. We are working to offer more challenging curriculum to talented and motivated students who do not meet the official qualifications of 'gifted'.
