8. Presentation by Mindy Clark and Kelly Baumgartner for the WPES STEM/Library

Mindy Clark gave a presentation on the STEM program at WPES to the BOE. She explained that she has 1 grade level for 1 trimester/12 weeks. The students learn engineering and design processes using robots. 5th grade is working with coding, while 3rd grade learned about Balloons on Broadway.

Kelly Baumgartner gave a presentation on creating a true connection between the STEM and library programs. Mrs. Baumgartner has been studying best practices regarding library instruction. This has led to many curricular changes focusing on students becoming critical thinkers, enthusiastic readers, skillful researchers and ethical users/creators of information. Examples at RGS include a construction unit and an Arctic inquiry/STEM unit. An example at WPES includes Passion Projects completed in 4th and 5th grades. Students used library and technological resources and were allowed to choose a subject and 'dig deep.' Student engagement was high in both settings!
